

German Army Gives Health Ministry "slap in the face" *but "only right decision," says German Virologist*

13 October 2009: German army health officials have ignited a fierce debate about the dangers of the "swine flu" vaccine by announcing on Monday that its soldiers are going to be given a completely different swine flu vaccine than the one ordered for the army by the German health ministry.

Virologist Alexander Kekule, head of the department of medical microbiology at Halle University, said that the army had "given a slap in the face to the health ministry" but had "made the only right decision" by deciding to give its 250,000 active duty soldiers a jab without mercury, without squalene and also with an inactivated virus. The army "doctors and advisors were simply more clever," he said in the German mainstream newspaper Die Welt.

The announcement by the army has increased the pressure on the German health ministry to explain why the rest of the people in the country are expected to take the untested and unproven "swine flu" jabs with mercury, adjuvants as well as a live virus in a campaign starting on October 26th. German Health Minister Ulla Schmidt tried to play down the significance of the army's decision by insisting there were three different swine flu jabs on the market and suggesting the army had just happened to chose the one without mercury and adjuvants.

However, it is accurate to say that there were three different manufacturers - Novartis, GSK and Baxter - providing the same standard swine flu jab with mercury and adjuvants on the market until the army, other German health officials and doctors insisted on having a jab without the dangerous preservatives and additives.

It appears that Baxter - the company compromised by having been caught trying to trigger a bird flu pandemic this february in Austria by contaminating 72 kilos of vaccine material with the live bird flu virus - has been sacrificed by WHO and the pharmaceutical companies that sit on its key vaccine boards and [has been] given the green light to switch over to produce a "harmless" vaccine without mercury and adjuvants to save face and also possibly ensure that nanochips -- widely believed to be in the jab - are implanted into as many people as possible.

The army's unexpected decision is fueling uneasiness about the mass "swine flu" vaccination campaign due to start in Germany on October 26th. Theodor Windhorst, the president of the chamber of doctors of Westfalen-Lippe, has said that the swine flu jab is associated with "significant risks." The number of leading doctors calling for swine flu jabs without adjuvants to be given to women and children has been steadily growing. Pregnant women, children and health care workers are among the target groups selected by the German health minister Ulla Schmidt, following the instructions of WHO, to be among the first to get the swine flu jab even though there is no clinical data on the adjuvant squalene in pregnant women or children. Under growing pressure, however, Schmidt this week said that pregnant women will now be advised to take the jab without the adjuvant, squalene, which is to be added at the last moment to form a toxic mix. Squalene is illegal in the USA and UK, and there is evidence it caused the Gulf War Syndrome, which afflicted 25% of the US and UK soldiers who took the anthrax vaccine, even though that vaccine had a million times less squalene than the "swine flu" jab.

German army health officials said that it was not clear how the "swine flu" jab would interact with the other vaccines German soldiers have to take, especially if they are sent on overseas missions, and also what the impact of the accumulation of toxic heavy metals might be.

"We are not something better, but something different," said an army spokesperson.

However, there are growing numbers of people in Germany wondering why they are expected to take

a "swine flu" jab by the Health Ministry that is considered too dangerous for the army. The decision by the German army to abandon the "swine flu" jab also raises the question of why other country's army leaderships are not open to feedback on the jabs' dangers, [nor] willing to assess new information and correct their vaccination plans. The US and UK army already have a large body of evidence that the anthrax vaccine caused significant auto-immune diseases in its soldiers, and yet these armies appear to be pushing ahead with its campaign to force every soldier to take the dangerous jab. The decision by the top level US military to implement the mass vaccination campaign of US soldiers at bases at top speed, will fuel fears that the US army, in particular, has been taken over by agents working for the "the banking elite," who control the WHO and UN, and who appear to be actively attempting to destroy the US army in order to pave the way for the occupation of America by UN soldiers and foreign mercenary troops in a "New World Order."

US army leaders who have raised questions about the mismanaged campaigns in Afghanistan and Iraq - triggered by the false flag 9/11 attack - have been silenced or forced to resign, leaving the military top heavy with government "yes" men.

The decision by the German army to refuse the "swine flu" jab is a significant blow to plans of the WHO and UN to carry through a synchronised and swift mass vaccination campaign across the USA and EU using bioweapons under the cover of a "vaccine" to accomplish their objective of depopulation and conquest. Crucial to accomplishing their aim of world domination under a WHO/UN/IMF government, is maintaining control of a country's military and law enforcement, at least long enough to use them to destroy the civilian population by vaccination and quarantines. The next step would require the army and police, having done its job, to be destroyed in turn, by disease or by igniting fresh wars. There has been speculation that soldiers and police might be given a vaccine with a disease that can be triggered by chemicals in water or some other means, allowing the disease to be activated at some preplanned point later on.

The danger now facing the "WHO/UN" bankster cartel is that other armies will refuse the swine flu jab - and that civilian populations will follow suit and demand a proper investigation into the "swine flu" scam, a move that will surely result in large numbers of arrests. Without a significant "culling of the population" and the installation of a comprehensive, electronic surveillance system using nano chips, the WHO/UN cartel will find it difficult to maintain control of their synchronised and coordinated programme to depopulate the world and set up a one world government, with the calculated use of economic collapse, war and famine, as well as the establishment of a totalitarian state to crush opposition and shut down the internet.
